## Setting a good example: the Agenda 2030 and the 17 Sustainable Development Goals (SDGs) as quality features for project management

### Context



Of course, development cooperation professionals are familiar with those colourful icons, representing the 17 sustainable development goals. The SDGs, the “new thing” to replace the MDGs – or is there more to it?

The 2030 Agenda itself consists of 4 sections: a political declaration, a set of 17 sustainable development goals and 169 targets, means of implementation and a framework for follow up and review of the Agenda.

While the relevance of SDGs for CSOs is evident, many CSOs nevertheless find it challenging to fully integrate the 2030 Agenda and the SDGs in their work due to the complexity of the topic.

How can we make the 2030 Agenda and the SDGs a key to a stable, peaceful, prosperous and equitable world?

To make the 2030 Agenda more than a “political PR effort”, it takes a strong civil society to claim pending measures towards more sustainability and to put forward the SDGs as arguments and incentives for political actions.

As far as CSOs project work is concerned, this means that the SDGs need to be embedded in their complexity and dynamics throughout the whole project cycle and furthermore on the organizational level on a daily basis.

One main objective of Global Responsibility’s project *SDG Initiative 2018* is to strengthen CSOs’ capacities to integrate the SDGs in their advocacy activities and work in the field, especially through peer-learning from good practice examples.

The workshop is an opportunity to deepen the knowledge about the transformative potential of the 2030 Agenda and the SDGs and concrete ways to integrate its principles into the work of CSOs.

### Purpose

In the framework of the project *SDG INITIATIVE 2018*, on the occasion of the EU Presidency of Austria, Global Responsibility offers to its member organizations, SDG Watch Austria and CONCORD a one day capacity building training on implementing the Agenda 2030 and the SDGs into their own project work.
