SECOND WORLD SUMMIT FOR SOCIAL DEVELOPMENT (WSSD2), QATAR

A collective letter from civil society organisations with demands for the WSSD2 process

To be sent to the UN, the host government Qatar, and co-facilitators (Belgium and Morocco) and to all UN Missions / Member states in UN - and copy all Major Groups and NGO Committee

Dear XXX

At the Financing for Development Summit in Seville the UN Secretary General, Antonio Guterres, addressed the CSO Forum, saying "You are the conscience of this process — and your calls for justice for the most vulnerable are being heard." He added: "I urge you to keep pushing. Keep demanding that governments live up to their promises. The leadership of civil society can inspire change for all of society."

We, the undersigned civil society organisations, represent millions of people for whom the outcomes of the Second World Summit for Social Development (WSSD2) in Qatar in November are just as crucial as the outcomes from Seville. In a world of rising inequality and injustice, WSSD2 must represent a positive moment of hope, making breakthroughs on everything from public services to universal social protection, from education to health, from gender justice to climate justice, from decent work to social care and support, from the impact of digitalisation and financialisation to human rights, equality, peace, migrant rights and civic space.

To ensure that the outcomes from WSSD2 respond to the needs of this moment, it is essential to ensure full and fair participation of civil society in the preparatory process of WSSD2 and in Qatar itself. For this reason, we have come together to lay out **ten core demands** for the WSSD2 process, demands that can help to ensure that the conscience of the world is heard.

- 1. We demand **time for full engagement with the WSSD2 Political Declaration**. Attempts to finalise the document too soon risk undermining the opportunity for all voices to be heard. We propose that the consultation on this document remains open to at least the end of September.
- 2. We demand sustained space and opportunities for coordinated civil society input directly into the outcome document, with a commitment to treat all inputs as seriously as inputs from member states. We can help to ensure that voices from the Global North and South are channelled in a coordinated and inclusive way.
- 3. We demand access to the WSSD2 for all ECOSOC registered organisations with active help from the organisers to ensure timely issuing of accreditation and visas.
- 4. We demand specific efforts to ensure that **representatives of children**, **youth**, **carers**, **older persons and persons with disabilities** are able to join the WSSD2.
- 5. We demand a **dedicated fund be established by the hosts and co-facilitators to support travel** and accommodation costs of CSO, self-advocates and child and youth delegates, with priority given to organisations from the Global South and those who represent the most excluded groups. We are happy to help with effective management of such a fund.
- 6. We demand full support from the UN, hosts and co-facilitators for a CSO forum to be held within the same venue as the conference itself, as organising an external space in Qatar would be nearly impossible. This should be for at least 2 days, perhaps overlapping with the first day of the main conference so that member states can also join concluding sessions. We demand a space to share the final declaration from that CSO forum in the main plenary session at WSSD2.

- 7. We demand that there is an **organising / meeting space for civil society** within the main venue throughout the WSSD2, ensuring that this is also accessible to member states.
- 8. We demand a voice for civil society in all plenary sessions, roundtables, panels and other sessions, along with a strong and clear message to all organizers of side events or sessions that they must include civil society representation. Special priority must be given to representatives of marginalised groups and to ensuring gender, caste, indigeneity, regional and age balance. If support is needed in identifying suitable participants for specific sessions, we are happy to assist and will ensure an inclusive range of voices is represented across different events.
- 9. We demand that all member states **include at least one national civil society representative in their official delegation,** with priority given to women in their diversity, persons with disabilities, youth, children, and older persons, ethnic minorities and socially and politically marginalised groups, to facilitate national accountability and follow up.
- 10. We demand the right for civil society organisations to bring into the WSSD2 space any rights-based printed materials, whether reports, briefings, posters, leaflets, banners, t-shirts and other materials carrying slogans and messages.

We would welcome the opportunity to discuss these demands with you at your earliest convenience.
