## Mainstreaming climate risk management and scaling locally led climate action in Humanitarian Assistance

The increase of weather-related disasters affects people living in poverty and marginalised communities most severely. Armed conflict, displacement and weak governance exacerbate their already restrained resources to protect themselves from those hazards and adapt to climate and environment crises. Humanitarian Assistance must strive to reduce impacts of climate change on vulnerable people by mitigating the rising risk through better early-warning, disaster relief, and climate-smart programming for WASH and food security.

The 2-days training will focus on

- climate smart programming, centering on the core elements of disaster management: preparedness, response and recovery
- building community resilience and community-based disaster risk reduction to enable people to better withstand shocks from natural and man-made hazards
- climate smart interventions to prevent and mitigate the effects of climate change on water availability and quality through increasing rainfall in certain regions and droughts in others, or water contamination through floods, and storms.

The highly participatory training is facilitated by experts from the **Red Cross Red Crescent Climate Centre** and part of the Austrian Development Agency-funded <u>programme to enhance the quality of Austrian humanitarian assistance</u>. It is open to employees of Global Responsibility member organizations working in humanitarian assistance and development organizations working with an HDP Nexus approach.
